- 3. Application fee: HK\$40 (to be collected together with the application form). If parents submit online application form, please pay at school. The application fee is non-refundable whether the application is successful or not.
- 4. Interview will be conducted on 1st November 2025, the interviewing time will be given to parents through email.

# Application for the "2026/27Registration Certificate for Kindergarten Admission"

- 1. Education Bureau (EDB) will implement the Kindergarten Education Scheme starting from the 2017/18 school year to replace the existing "Pre-primary Education Voucher Scheme". Under the new Scheme, EDB will use the "Registration Certificate for Kindergarten Admission" as the document for registration in the 2026/27 school year.
- 2. Parents are required to submit an application for the "2026/27 Registration Certificate for Kindergarten Admission" (hereafter referred as "2026/27 RC") to EDB from September to November 2025. The "2026/27RC" will be open for applications in September 2025 and EDB will announce and upload the details of application onto EDB'swebsite.

#### **Admission Criteria**

- 1. The applicant with sibling(s) currently studying in the kindergarten will be given due priority consideration
- 2. Interview performance

## **Interview Arrangements**

- 1. An interview will be arranged by our kindergarten for all K1 applicants.
- 2. Interviews will be conducted on 1st November 2025 (Saturday)
- 3. Group interviews will be arranged
- 4. Parents should accompany their child for the interview

#### **Announcement of Admission Results**

We will inform parents of the K1 admission results on 5<sup>th</sup> November 2025 by post and school web page.

## **Registration Arrangements**

- 1. Successful applicants: Parents should complete the registration procedures for their child from 8 to 10 January 2026 ("Centralised Registration Dates") by submitting the Electronic Registration Certificate for Kindergarten Admission / Kindergarten Admission Pass or screenshot of the QR code on the Electronic Registration Certificate for Kindergarten Admission / Kindergarten Admission Pass to the Kindergaten and paying the registration fee.
- 2. Applicants on the waiting list: The kindergarten will notify parents by post and telephone according to the situation in the school. Parents should complete the registration procedures for their child according to the specified date set by the school. Parents are required to submit the Electronic Registration Certificate for Kindergarten Admission / Kindergarten Admission Pass or screenshot of the QR code on the Electronic Registration Certificate for Kindergarten Admission Pass to the Kindergarten and paying the registration fee.
- 3. Please be reminded that if parents cannot submit a valid electronic registration document or screenshot of the QR code to the school during registration, the kindergarten may not be able to complete registration for their child. Parents are required to submitt application for the registration document to EDB within the specified period.
- 4. (a)The child of Half day class: The registration fee for 2026/27 K1 place is HK\$970. If the child confirmed studies in the kindergarten, the registration fee paid will be refunded in September 2025. Should parents decide to change school after registration, please notify the kindergarten in writing. <a href="https://doi.org/10.1007/jhe-kindergarten-will-complete-the-de-registration-as-soon-as-possible-but-the-registration-fee-will-not-be-refunded">https://doi.org/10.1007/jhe-kindergarten-will-not-be-refunded</a>. Upon de-registration, the kindergarten will no longer keep the school place for the child.
  - **(b)The child of Whole day class:** The registration fee for 2026/27 K1 place is HK\$1570. If the child confirmed studies in the kindergarten, after deducting fee, the balance will be refunded in September 2025. Should parents decide to change school after registration, please notify the kindergarten in writing. **The kindergarten will complete the de-registration as soon as possible but the registration fee will not be refunded.** Upon de-registration, the kindergarten will no longer keep the school place for the child.
